The managers also had the opportunity to meet the new League of Oregon Cities Executive Director and discuss the upcoming legislative session and some of the changes and new services that may be coming from the League.

Utilities Division

On Monday, July 23rd, Hayden Jones will be transferring from the Maintenance Division to the Utilities Division. Hayden has worked the past year in a part-time position maintaining City parks and facilities. The new position with the Utilities Division is full-time working on the City's streets, water distribution, sewer collection, and storm drainage systems. Congratulations Hayden.

Mosby Creek Pond

On Wednesday, the Public Works & Development Director and Water Treatment Plant Superintendent were given a tour of Weyerhaeuser's former mill pond on Mosby Creek. The purpose of the tour was to check for Blue-Green Algae and how the pond connects to Mosby Creek. Mosby Creek flows into the Row River just above the City's water intake feeding the water treatment plant. Staff didn't see Blue-Green Algae present in the pond and the volume of water entering Mosby Creek from the pond is very low. Staff would like to thank Maryanne Reiter and Lyndcy Patrick for giving the tour.

Algae Test Results Update

The water treatment staff has been taking weekly samples of the water coming into the treatment plant for cyanotoxins that could be produced by Blue-Green Algae. The tests results for the past four weeks have come back negative (less than detectable level of the laboratory testing limits) for the presence of the cyanotoxins. Under temporary new rules adopted by the Oregon Health Authority staff will be continuing the tests every two weeks throughout the remainder of the summer. The water samples will be sent to Oregon's Department of Environmental Quality State Lab in Hillsboro, Oregon. The Oregon Health Authority pays for the tests.

Wildfire on ODOT Property

This past Sunday afternoon, South Lane County Fire & Rescue extinguished a small grass and brush fire on ODOT property just north of Middlefield Golf Course. The cause of the fire has not been determined at this time. This is a reminder during these hot dry days to please take extra precaution when engaging in activities that can start unwanted fires.

Fire Danger Level is HIGH

Earlier this week Western & Eastern Lane Districts of Oregon Department of Forestry, along with South Lane Fire & Rescue (SLCFR) moved to the HIGH level for fire season restrictions for regulated activities. Until further notice from SLCFR, no mowing of dry grass is permitted from 10:00 am to 8:00 pm. This applies within the City limits and rural areas in Lane County. There have been several wildfires started recently, so please use caution during this period of dry and hot temperatures.
