# **Budget and Audit Committee Recruitments – Deadline Extended**

Currently there are three positions vacant on the Budget Committee. If you have ever wanted to be involved in creating the City Budget here's your opportunity. The City Council invites registered voters who reside within the City limits to apply for participation on the City's Budget Committee. The Budget Committee generally meets twice in the spring of each year to consider the budget proposed by the City Manager for the following fiscal year. The committee makes any changes they feel are needed and then approves the budget and forwards it to the City Council.

The Audit Committee meets on a very limited basis to review the City's Comprehensive Annual Financial Report, or in other words, the annual audit statements prepared by an outside auditing

firm. The Committee after reviewing the annual audit document with the auditors, recommends action to the City Council regarding the audit. The Audit Committee is comprised of two City Councilors and three citizens. Presently, there are two vacant citizen member positions.

# Audit Report Issued For Fiscal Year Ending June 30, 2019

The City's Comprehensive Annual Financial Report (Audit) for fiscal year 2018-19 was issued December 31, 2019, meeting the deadline established by law. The report has been provided to S&P Global Ratings as the City has debt outstanding that is currently rated by them and posted on the Electronic Municipal Market Access (EMMA), which is a service of the Municipal Securities Rulemaking Board and meets the continuing disclosure requirements of the Exchange Act. The Audit has also been posted on the City's webpage.

The Audit Committee will be meeting sometime in January or February to review the Audit with the City's Auditors. Members of the Committee, the City Manager, and the Finance Director will receive the document and review the information presented. The Audit Committee will fulfill its responsibilities for oversight of the City's financial reporting, and make a recommendation concerning the report to the City Council once they have finished their review.

## **Silk Creek Restoration Update**

The Kennedy School Conservation Corps, under the leadership of Matt Hall, has been undertaking riparian restoration at Silk Creek Park. Blackberry, ivy, Knotweed, and other invasive plants have been removed from the river bank. Native bushes and trees will be planted in these areas in a few weeks, to provide soil cover and stabilization and habitat for native wildlife. The students' work on this property is greatly appreciated by the City.
