League Coronavirus Relief Fund Conference Call

The City Manager attended the virtual Coronavirus Relief Fund (CRF) Brown Bag lunch held by the League of Oregon Cities. The call went over questions regarding eligible reimbursements and how to request reimbursements from the CRF. League Staff also provided an update on the changes and some of the negotiations that are ongoing to increase the resources or the eligible expenditures. Of the funds \$53.6 million is set aside for local governments Cottage Grove has been initially allocated \$328,944.98 available for eligible reimbursements. In the first reimbursement So far we have received \$30,871.00 for expenses that the City incurred related to COVID-19 response from the CARES Act through the Coronavirus Relief Fund.

COVID-19 Requirement Changes

On Wednesday, July 22, Governor Kate Brown announced new statewide requirements that become effective today:

- Face coverings are required for ages 5 and up. Children who are three and four years old are recommended, but not required, to wear a mask, face shield or face covering as long as they're able to remove it themselves.
- Restaurants and bars must close at 10 p.m. statewide.
- Face coverings are required when exercising indoors, plus outdoors when you can't physically distance.
- The maximum indoor capacity limit is capped at 100 for all venues, such as larger restaurants, bars, community centers, churches or other houses of worship, movie theaters and gyms.

Governor Brown also announced that her team, in coordination with the Oregon Health Authority, is looking into further restrictions on tourists coming from states that are currently considered hotspots, and is evaluating the counties on the state's watch list. She said announcements could be out early next week. While we realize these changes are difficult, it takes the entire community and state working together to make a difference and stop the spread of COVID-19. We can all help by practicing the 4 "W"s. It's up to all of us to do our part. Help protect yourself and others:

- 1. Wear a face covering indoors and out, it's a statewide requirement.
- 2. Watch your distance stay 6 feet apart from those outside your household.
- 3. Wash your hands often with soap and water for 20 seconds throughout the day.
- 4. Wait it out stay home if you are sick.

Last weekend would have been Bohemia Mining Days 2020. In place of the full BMD festival representatives spent the weekend in Coiner Park reminding everyone that BMD will be back next year. To support BMD, everyone was encouraged to give BMD a buck. As a result of the donations from community members BMD raised \$1,667.44. Thank you to everyone that supported BMD.

Free Masks for Small Businesses

Please remind any small business owner that the City has free disposal face masks/coverings that are available for small businesses (50 or fewer employees). The masks can be picked up at City Hall, Monday through Friday 8:00 am to noon, 1:00 to 5:00 pm. The masks were provided by the Oregon Office of Emergency Management and are for small businesses to share with their staff.

Historic Renovation Grants Available

The Cottage Grove Historic Landmarks Commission is accepting Historic Renovation Grant applications for the 2020-2021 fiscal year. Applications are due to the Public Works & Development Department by August 31, 2020.

This program is designed to assist Historic Downtown business & property owners with needed historic renovations. All projects must be located within the National Register Historic District, and must be for exterior work. Past projects funded through this program include the restoration of neon signs, repainting historic murals, window repairs, brick & mortar repair, stucco repair, restoration studies, and new awnings.

A total of \$10,000 in City funds will be distributed between successful applicants. Typical grant awards are for between \$500 and \$3500. Each applicant must match this award at a 1:1 ratio. Projects must be complete by June, 2021.

This is the eighth year of this grant program. Prior recipients have included the Cottage Grove Hotel (new awning), Burkholder Woods (corbel repair), Mortier Building (Coca Cola mural, masonry repair), 802 E. Main Street (new stucco, roof repair), the Bookmine (awning and siding repair), and the First National Bank (masonry cleaning, windows repair).
