Last Day to Register to Vote

Ballots will be mailed on October 15th. If you don't receive your ballot within a week, contact the Lane County Elections Department, (541) 682-4234. Once you have voted you can either mail in your ballot or you can deposit it at one of the Lane County Drop Sites located on the attached map. The drop site in Cottage Grove is located at the Community Center on Gibbs Avenue. If you choose to mail your ballot there is no postage required this year, however your ballot must be received by 8:00 pm on Election Day.

Local Foods Local Places Workshop
