Construction Season is Here

The warmer longer days are finally here and work is getting underway on road and other projects. The Oregon Department of Transportation has created a website with project location maps and schedules to show you what is happening on the roads in and around your community. The tools can help you find the best route to get where you need to go and to help you move through or around construction areas. View construction projects across the region, or zoom in on a specific county. In Cottage Grove construction is under way on several projects. Below are this week's updates on the Water Treatment Plant Expansion, the Recycled Water Storage and Pump Station, and the Safe Routes to School Project on East Harrison and South 4th Street. Water Treatment Expansion Project

The expansion of the City's Water Treatment Plant by contractor, Pacific Excavation, Inc., continues on-schedule with a new membrane filter rack expected to be delivered during the week of June 15th. Assembly and installation by the subcontractor, PALL Corporation, will begin during the week of June 22nd. Current production capacity is 4 million gallons per day. Once completed in late summer, 2020, the project will expand the City's ability to produce up to 6 million gallons of water per day.

The Water Treatment Plant project is on schedule for completion and to be operational by September, 2020.

Recycled Water Storage and Pump Station Project

R&G Excavation continues their work at the City's Wastewater Treatment Plant, currently focused for the next two weeks on the construction of berms for the storage of millions of gallons of treated effluent during the warm months of the year. Because discharge is limited to the Willamette River during the warm months of the year, the City will have greater capacity to pump the stored water to the City's golf course, ODOT's I5 interchange and various City parks.

The Recycled Water Storage and Pump Station project is on schedule for completion in January 2021.

<u>Safe Routes To School & Fillmore Stormwater Outfall Project Update And Schedule For</u> <u>Week Of June 15</u>

This week Wildish Construction has been working around the water quality swale by installing 27 inch storm drainage pipe. Next week work will continue in this area with installing 12 inch storm pipe as well as beginning to shape the water quality swale.

Work will begin on South 4th Street next week. On Monday, designated trees will be removed. Asphalt/Concrete saw cutting will begin. This work will start at the intersection of Grant and South 4th Street moving north along South 4th to Taylor Avenue.

Tuesday, crews will begin taking the asphalt layer off South 4th Street. Gravel will be placed at the driveway approaches for a smooth transition.

Northwest Natural Gas will continue working within the project area relocating their facilities. A meeting is scheduled with Pacific Power Tuesday for relocating their facilities that conflict with project.

Yard of the Week

The Yard of the Week is 247 S 2nd Street. This is a beautiful two-story historic home with a gorgeous yard. The yard has a freshly trimmed hedge that is adjacent to the sidewalk on the east and south side of the yard. There are a mix of beautiful pink and purple FoxGlove flowers that range 5' to 6' in height and are very fragrant from the sidewalk.

The Latest Scam

The fraudsters have found another way to scam you and get your personal information. The Oregon Health Authority wants to make sure everyone knows what contact tracing is and the questions that will be asked. Apparently there are scammers that are calling and asking for unnecessary personal information. It is important to answer the call from a contact tracer as the information may be vital for your health and that of your family.

Official contact tracers will identify themselves as from a local or tribal public health authority. It will not be an automated recording – contract tracer calls will always be a real person.

An official contract tracer will ask you:

- If you need an interpreter in a language other than English.
- For you name, date of birth and where you live.
- If you have any symptoms of COVID-19.
- If you need a place to stay.
- If you need food or have other needs to help you stay home.
- If they can contact you daily to monitor your symptoms and needs.

A contact tracer **will never** ask for your:

- Social Security Number.
- Bank account or credit card number.
- Immigration status.

The caller **will not**:

- Say you need to pay for this service or,
- Make a threat to put you or your family in jail if you don't speak to the contact tracer.

Parklets

On June 8, 2020 the City Council approved a pilot Parklet program for 2020 and 2021. Public Works & Development Staff are currently accepting applications for Parklets on East Main Street between 8th Street and River Road. Parklets are intended for restaurants to add dining space on decks that are constructed within a parking space in front of businesses on E. Main Street. Staff began receiving applications this week and the City Council is expected to review and potentially approve parklet locations at the June 22nd Council Meeting. Construction of parklets could begin soon thereafter, pending completion of all legal requirements and final inspections of the decks and railings.

Row River Water Treatment Plant Superintendent Retirement

On June 30, 2020 Ray Pardee is retiring after 30 years working for the City. Ray has spent his career working for the Water Treatment Division of the Public Works & Development Department.
