Bohemia Mining Days is Here

The 62nd Bohemia Mining Days celebration is here. This weekend the festivities kickoff with the Grand Miners Parade on South 10th and East Main Streets starting at 10:00 am. Vendors will be located downtown on 6th, 7th and 8th Streets from noon after the parade, as well as the Farmers Market on south 7th. Entertainment will begin at noon as well on the Main Stage that will be located in the parking lot behind All-America City Square. The real fun begins at 5:30 when Main Street will be closed and the Kiddie Parade will circle through the downtown. After the Kiddie Parade the Ore Cart time trials will begin on Main Street. Saturday's events will end at 9:00 pm. Events on Sunday will begin at noon until 6:30 pm.

Taxes Certified - Budget Document Available On City's Website

Every year by July 15th, local governments that have the authority to impose ad valorem property taxes or another tax on property are required to give notice of the tax they are imposing to the County Assessor per ORS 310.060(1). Besides specifying the rates or amounts being requested, the City must certify to the Assessor that we have the authority to place such amounts on the tax roll and that we have complied with State Budget Law. If certification is not received by the County by July 15th, the Assessor is prohibited from extending those taxes on the property tax roll for that year. Rest assured, the City has filed the required LB-50 form with the county assessor to certify the property taxes for Fiscal Year 2021-22.

Gateway Blvd. Chip Seal Project

On Wednesday July 21st, Sierra Santa Fe Corporation will be chip sealing Gateway Boulevard from East Main Street north to Harvey Road. On July 26th, they will apply a sealer called Liquid Road completing the project. Property owners and users will experience up to 15 minute delays when entering or leaving their property on Wednesday July 21st and up to 2 hour delays on July 26th. Chip sealing roads is a process that coats the road surface with a fine 1/4 inch sized gravel and oil mixture that renews the road surface and extends the life of the road from 5 to 7 years. Applying Liquid Road fills voids in the chip seal, smoothing the surface and further extends the road surface life.

Street Striping Repainting

On July 27th and 28th, Lane County will be re-striping all the City owned streets. Lane County will start early evening on Tuesday, July 27th and finish the following morning working through the night. City Utility Crews will set up barricades and no parking signs Monday, July 26th. It is important that the no parking signs are followed to allow for all the street striping to be repainted.

Crack Seal Update

This week City Utility Crews completed crack sealing on River Road from Harrison Avenue to Woodson Bridge. Next week they will start cleaning and resealing cracks on East Main Street from Hwy 99 to Gateway Boulevard. The crew will be starting at 5:00 am in an effort to work when traffic is less congested and the temperatures are lower. Please watch out for lane changes and flaggers when traveling through the work zones.

Effluent Irrigation Expansion Project

The Effluent Irrigation Project at the 174 exit from I-5 is proceeding on schedule. The contractor is currently working on the west side of I-5. Once completed they will move to the East side of the freeway to complete the irrigation installation. The new irrigation system at the 174 interchange will add approximately 15 acres of grass land to apply treated effluent from the Wastewater Treatment Plant. Currently 450,000 to 650,000 gallons of treated effluent is used at Middlefield Golf Course. The addition of irrigation in the interchange will allow for the use of an additional 200,000 gallons per day. This helps the City comply with the water temperature requirement set by the DEQ in the Wastewater Treatment Plant's Discharge Permit.

Fire Danger Level

The fire danger moved to Extreme on Wednesday due to the high temperatures and low moisture content. Under the Extreme level mowing of dry grass and brush is prohibited. The lower temperatures on Thursday and Friday allowed for the fire danger to be lowered to High allowing for dry grass and brush cutting until 10:00 am and after 8:00 pm. Please use extreme caution when operating combustion motors during the approved hours. As demonstrated this week, the fire danger levels can change daily. Mobility Hub Survey

The City of Cottage Grove and South Lane Wheels are partnering to design a mobility hub that meets the transit needs of the community. As part of the research, we would like input about mobility hub needs.

A mobility hub is a centralized location where many different forms of transportation meet up to make using transit even more convenient. The study that is being created will be separated into three parts. The first part is to identify what a transit hub generally would need, as well as identify what the Cottage Grove community would want in a centralized transit area. Staff will then evaluate locations and identify current, proposed, and long range uses and how the mobility hub could work within these plans. Lastly, we will examine how these two overlap and decide how to properly build this for the community.

The survey is to gain the community's input on what kind of additional transportation modes you would like to have access to in our community. Coast Fork Construction will be finishing up the framing this Saturday. I will be out there most of the day organizing, painting cabinets on the sub-floor and evaluating our job-site materials, and what I will need to button up the exterior. There are also a couple of pick-up items I would like the framers to take care of. The windows will be in August 11th and 12th, and Boyd indicated they would come back out and set them for us. I will be having a check cut for Coast Fork Construction, so that they get paid in full. They did an excellent job, and we think Boyd and his crew tremendously.





Dan Wilson will be coming out Monday to dig the trench so that we can install the power to the house. This will entail an inspection by EPUD.

I also will be calling in Lane County for an inspection for our exterior shear-walls on Monday, which will allow Travis Prine and Northwest Siding to come in and get started on installing the finished siding. I still need to get the Vycor sticky

flashing and caulk for the siding install.

Jayson, Misty and I met with Marty of Superior Electric in order to ensure we get can lights, switches, and other options the way they would like. It is very important for my son Jason E. Bush, of Harvey & Price to coordinate the reflected ceiling penetrations of the various trades so that the installations are aesthetically pleasing. Marty indicated that they may be able to follow Dan late PM Monday and install the power, but may end up doing it Tuesday or Wednesday.



McKenzie Roofing indicated that they will try to dry it in this weekend with the Tiger Paw underlayment, but may fall back to the first of next week. Once all trades have secured their roof penetrations, McKenzie will come back and install the roofing material.



Brothers Plumbing is scheduled for the week of July 26th, but are working hard to get in next week. Once Brothers is done or getting close, Priority One Heating and Cooling will come in on their backside. Then the plan is to have Harvey and Price and superior electric come in together as much as possible to finish up their part
