## **COVID 19 Vaccine Clinic**

#### Budget Committee Recruitment - Deadline: Friday, April 16, 2021

The City is seeking applications for one open position on the City of Cottage Grove Budget Committee. The appointee will serve the balance of a vacated term which expires December 31, 2023. The Budget Committee reviews the City's financial plans and policies, including the annual budget. The 14-member Committee is comprised of the Mayor and six City Councilors and seven members from the community.

If you have ever wanted to be involved in creating the City Budget, here's your opportunity. The City Council invites registered voters who reside within the city limits of the City of Cottage Grove to apply for participation on the City's Budget Committee. The Budget Committee generally meets twice in the spring of each year to consider the budget proposed by the City Manager for the following fiscal year and can also meet on an "as needed" basis. The committee makes any changes they feel are needed and approves the budget to forward on to the City Council.

received through Friday, April 16, 2021, at 5:00 p.m. It is anticipated a Sub-Committee of the City Council will review the applications received and make recommendations for appointments to the Committee. ## **Tree City USA Awards and Arbor Month**

Cottage Grove received Tree City of the Year this year for the 27th year in a row and the Growth Award for the 4th consecutive year from the Arbor Day Foundation. Arbor Day Foundation in partnership with the U.S. Forest Service and National Association of State Foresters established the Tree City USA program. More than 3,400 communities have made the commitment to becoming a Tree City USA. Cities achieve Tree City USA status by meeting four core standards of sound urban forestry management: maintaining a tree board or department, having a community tree ordinance, spending at least \$2 per capita on urban forestry and celebrating Arbor Day.

The Tree City USA Growth Award is presented by the Arbor Day Foundation to participating Tree City USA communities that demonstrate higher levels of tree care and community engagement during the calendar year. The Growth Award recognizes major milestones and annual activities in five categories that combine to build sustainable community forestry programs over the long term. Each activity has a value between 1 and 10 points, and communities must document activities that total at least 10 points, from any of the subcategories, to receive the Growth Award for the calendar year. The subcategories are: building the team, measuring trees and forests, planning the work, performing the work, and the community framework.

City staff, the Urban Forestry Committee, and citizen volunteers work diligently each year to improve the health of trees in our community. Trees are trimmed, new trees are planted, tree assessments are performed, and support for Arbor Day helps in improving the health of trees. April is Arbor month. Staff is preparing a Proclamation for City Council adoption at their April 12, 2021 City Council Meeting.

### **Virtual Meetings**

It has been a year since the City started holding virtual meetings as a result of the COVID-19 pandemic. To help demonstrate the impact that virtual meetings have had on City Councilors, Committees and staff, we have some numbers that summarize our virtual meetings held on our GoTo Meeting platform (the following numbers do not include other meetings on Zoom, Teams

or Google Meet). In the last year, the City held 327 virtual meetings with a total of 2,253 attendees during those meetings. The average meeting had 7 attendees with the largest meeting having 67 attendees. The total number of minutes of our virtual meetings for the year was 19,082.

## I-5 Interchange On/Off Ramps Garbage Pickup

Wednesday City staff from the Utility, Maintenance, and Golf Course Divisions worked to pick garbage up at the on and off ramps from I-5 at Exit 174. Late last year Cottage Grove and the Oregon Department of Transportation signed an Intergovernmental Agreement allowing the City to irrigate the interchange with the stipulation that Cottage Grove performs routine maintenance of the interchange. With the grass growing season upon us City staff picked up the garbage ahead of the grass mowing. It is the City's goal to keep the interchange well maintained and green, improving the entrance into our wonderful City. A huge thank you goes out to all the City staff for cleaning up the interchange. They removed over 1,500 pounds of garbage.

#### **New Willamette River Basin Mercury Regulations**

On March 5, 2021 the City received notification via certified mail from the Oregon Department of Environmental Quality (DEQ), regarding changes to the Water Quality Management Plan for the Willamette Basin, specifically regarding Mercury. The U.S. Environmental Protection Agency (EPA) adopted new Total Maximum Daily Load (TMDL) limits for Mercury on February 4, 2021 and provided it for DEQ to implement. The notice states Cottage Grove will have until September 3, 2022 to submit a TMDL Implementation Plan meeting the new TMDL requirements set by the EPA. If a plan is not submitted within the required timeline Cottage Grove will be subject to civil penalties that are assessed for each day of the violation. Click here to view the letter.

#### **New Row River Water Treatment Plant Employees**

The City completed a recruitment and hiring process for two entry level Operator-in-Training positions at the Row River Water Treatment Plant. There were 49 applications submitted during the recruitment process. The applications were scored and 5 individuals were interviewed. All 5 individuals interviewed have current or past water treatment training and or experience. The recruitment was initially intended to fill one position. During the interview process the City learned that Sam Haynes is intending to retire on April 29, 2021. With the impending retirement Treatment Plant Staff took advantage of the large pool of applicants and was able to hire a second person. The City would like to welcome Luke Perdue and Jayson Veenker as new operators-in-training at the Water Treatment Plant. We're excited to have them on staff and look forward to their contributions to the City.
