#### **OVERVIEW**

The Special Trusts fund accounts for the interest earnings on a \$3,000 fixed principal donation by the estate of Ed Jenks to the Cottage Grove Library. Expenditures are restricted to purchases of non-fiction books for the Library.

Funds earmarked for the Memorial Tree Program, which allows individuals to have a tree planted on City property and maintained in perpetuity, as established by the City Council in 2000, are also kept in this fund.

In an on-going effort to be of support to customers that need temporary assistance with utility bills, the City partnered with Community Sharing and developed the  $H_2O$  Program (Help to Others). Customers may round-up or designate a specific amount to be used for the assistance program. The money collected and expended is accounted for within this trust fund.

Miscellaneous donations made for various projects and purposes are budgeted for in this fund. They include the following: restoration of the Chambers Railroad Bridge, Armory building restoration, Police K-9 program, the H<sub>2</sub>O Program, and for a Civil War Exhibit at the Library.
