Gran Fondo

The cyclists are coming. The 2016 Gran Fondo, the first event of the Oregon Triple Crown series, is coming to Cottage Grove on Sunday, June 5th. Over 400 cyclists are expected to start in downtown Cottage Grove at 8:00 am for both the Gran and Medio routes. The Gran route is 117 miles and the Medio is 71 miles. The first riders for the Gran would be expected about noon while the faster Medio riders might begin returning about 11:00 am. By definition, a Gran Fondo is not a race, but rather a mass start event designed to draw the community together and give everyone a chance to enjoy the fun of riding a bike on the same course as the pros. It is truly a ride for everyone! At The Oregon Gran Fondo, teams and individuals, who want to race, will typically do that on the 117-mile Gran route, but both routes are open to anyone willing to accept the challenge.

Those not interested in facing the challenge of the ride are encouraged to come downtown and experience the mass start at 8:00 am or watch the riders come back in before noon. Please make plans to come and share the excitement of Oregon's largest Gran Fondo.

NOAA Fisheries West Coast Region Releases "Critical Habitat Biological Opinion"

Last Thursday NOAA Fisheries issued a 400 page Biological Opinion for the State of Oregon as a result of the Federal Emergency Management Agency (FEMA) consulting with NOAA Fisheries under Section 7 of the Endangered Species Act (ESA). The consultation was a result of a settlement by FEMA with The Audubon Society of Portland, National Wildlife Federation, Northwest Environmental Defense Center and the Association of Northwest Steelheaders who argued that federal flood insurance program was encouraging development detrimental to the

survival of listed species. Throughout the state, 15 salmon and steelhead species are listed under the ESA, and each of these species depends on healthy, functioning floodplain habitat. Development in floodplains can disconnect this important area from river channels and destroy natural riparian and wetland vegetation. Altering the natural processes that allow habitat to form and recover from disturbances, such as floods, can affect multiple stages of the salmon life cycle and impede their survival and long-term recovery.

What is the National Flood Insurance Program?

The National Flood Insurance Act (NFIP) of 1968 created the National Flood Insurance Program. It is a federal benefits program, administered by FEMA, and has three components—it: 1. identifies flood risks and maps them; 2. sets building and development standards for those flood risk areas; and 3. provides subsidized insurance for communities that adopt those standards. It is a voluntary program except in Oregon where our Statewide Planning Goals require participation. Oregon has 258 cities and counties that are subject to flooding, and all participate in the NFIP thereby making flood insurance available to their residents and businesses. In order to be eligible for federal flood-related assistance communities must participate in the NFIP.

What role does NOAA Fisheries play in administering the National Flood Insurance Program?

NOAA Fisheries does not administer FEMA's National Flood Insurance Program. Rather, NOAA Fisheries reviewed the effects of program implementation in Oregon to ensure it does not limit the survival of threatened and endangered species protected under the ESA, nor adversely modify their critical habitats. This is known as an ESA Section 7 Consultation. It is a legally required process for all federal activities that may impact plants and animals that are listed as threatened or endangered. At the end of the consultation process, NOAA Fisheries released a biological opinion with its findings. NOAA Fisheries found that implementation of the NFIP in Oregon reduces the quantity and quality of floodplain and in-channel habitat, which will jeopardize the continued existence of 17 marine and anadromous species, and adversely modify critical habitat for the 16 of these species.

What is recommended in the biological opinion's reasonable and prudent alternative (RPA)?

Key elements of the RPA include:

1. Updating floodplain maps to more accurately identify where flood risks are and where they are expected under future conditions. This information is critical to avoiding floods and preserving those areas needed to support salmon survival. \
2. Limiting the types of development allowed in floodways and channel migration zones to flood-compatible uses, since these high risk areas also have the highest habitat values.
3. Tracking floodplain development and require mitigation of the impacts of development to ensure that floodplain features are not lost that are critical to supporting the survival and recovery of listed species.

In addition, the RPA also recommends:

Interim Measures for Immediate Implementation – The RPA provides provisions that should be implemented in a timely fashion, with local governments showing progress within six months, and full implementation within two years. These provisions specify that development in floodplains must mitigate for the loss of flood storage, reduction in vegetation, and placement of impervious surface.

Data Collection and Reporting – Locally issued permits for development in special hazard areas need to be reported to FEMA, and reports need to include: how much flood displacement by fill or structures; how much new impervious surface added; how much vegetation removed; whether floodplain is disconnected or reconnected; and location of development actions and mitigation for floodplain impacts.

Compliance and Enforcement—It will take FEMA a number of years to fully implement the RPA. The RPA increases the Community Rating System for early compliance; requires audits/Community Assistance Visits for communities that fall behind schedule in implementation; and sets probation and expulsion requirements for persistent non-compliance.

Oregon Department of Land Conservation and Development (DLCD) has created a webpage on this issue and provided notice to local governments titled: “**Oregon Seeks Common-Sense Approach to New Floodplain Development Expectations**”. A copy is attached.

Floodplain Managers Attend Advanced Training

This advanced floodplain management course was a dynamic and interactive course covering National Flood Insurance Program Floodplain Rules and Regulations in Depth, Local Floodplain Manager Roles and Responsibilities, Letters of Map Change and Preparing for Post-Disaster Responsibilities. One of the instructors was the Region

X ESA & NFIP Coordinator for Oregon which provided an excellent opportunity to discuss the Biological Opinion which was released by FEMA during our course.

New Permit Tracking Program

The City was one of the original 14 cities/counties that implemented the D-14 Accela permit tracking for building permits in 2011. The program since that time has grown and a “standard model” has been developed which includes more features and planning application tracking. Cottage Grove will switch over to the standard model this weekend and go live with the new program on Monday, May 2nd. Staff is excited about this opportunity and the ability to directly link building, planning and engineering applications in one program. The program is also more robust in the number and type of reports that can be produced. The program is paid for by the State through the state surcharge on all building permits.
