# **Cottage Grove State Airport Annexation**

The annexation of the Cottage Grove State Airport is in the final stages of the process. In September of 2015 the State Aviation Board voted unanimously to annex into the City. City Council in January of 2016 voted unanimously to initiate the application for annexation. Since that time the legal description and map have been created. The ordinance to annex the property has been prepared. The proposal is being processed using the expedited process and is out for comment at this time. ONLY the State Airport property is being annexed. No privately owned property is part of this application. Once the annexation is complete the City and State Aviation Department staff will initiate a rezone application and develop a master plan for the airport property. #### "Can You Hear Me Now"

On Monday of this week, 44 City employees from the Police Department, Middlefield Golf Course, Utilities, Building Maintenance, Shop, Water, and Wastewater received hearing tests. Employees in job classifications within these City function areas are routinely exposed to loud or repetitive noise. City policy requires employees to use hearing protection when working in loud or repetitive noise environments. Annual hearing tests create a baseline level for each employee that can be monitored for any significant changes. These tests also give us a good opportunity to reinforce the importance of using hearing protection when exposed to loud or repetitive noises. Annual hearing tests are part of the City's on-going health and safety program. Follow-up hearing tests will be scheduled for those employees that missed the test because of shift or leave conflicts.

#### **Row River Water Treatment Plant in the News**

Version 2.0 Communications of Boston and New York recently contracted with Pall Corporation to prepare several case studies of Pall membrane water filtration plants around the country. One of these case studies specifically highlighted the Row River Water Treatment Plant. This week, Ray Pardee, Water Production Superintendent was notified by Version 2.0 Communications that

the trade publication, *Treatment Plant Operator* is interested in publishing a summary of the Row River Water Treatment Plant case study in the publication's November, 2016 issue. This will coincide with that issue's editorial focus on "Treatment and Filtration". This trade publication is delivered to 75,000 municipal water treatment operators and is read online by an additional 13,500 professionals each month.

## **Vehicle and Equipment Repair and Maintenance**

With the close of the FY 15-16 budget, it is interesting to note what the City spends on vehicle and equipment repair and maintenance services during a fiscal year. The City Shop repairs and maintains vehicles and equipment for all City departments. Total equipment and vehicle repair costs, for Fiscal Year 2015-2016, were \$72,845. This amount was generated by a total of 303 repair orders. During the previous Fiscal Year (FY2014-2015), total vehicle repair costs were \$69,275 for a total of 277 repair orders.

### **Award-winning Storyteller Visits the Library**

Over 40 people enjoyed the library's summer reading performer last Wednesday.
