Marijuana Advertising - If You See Something, Say Something

Lane County Public Health provided the following information about marijuana advertising. Did you know that marijuana advertising must contain three warning statements? If you see any marijuana advertisement that is out of compliance, say something. Snap a picture of the advertisement, provide the name and address of the marijuana dispensary with a short description of the advertisement and where it was found and email it to marijuana@oregon.gov

According to Oregon State Law ORS 845-025-8040 "A licensee must include the following statement on all print, billboard, television, radio, and internet advertising in font size legible to the viewer:

- a) Do not operate a vehicle or machinery under the influence of this drug
- b) For use only by adults twenty-one years of age and older
- c) Keep out of reach of children

Marijuana advertising may not:

- 1. Make claims that recreational marijuana has curative or therapeutic effects;
- 2. Contain statements that are deceptive, false, or misleading;
- 3. Display consumption of marijuana items;
- 4. Contain material that encourages the use of marijuana because of its intoxicating effect;
- 5. Specifically encourages the transportation of marijuana items across state lines;
- 6. Contain material that encourages excessive or rapid consumption;
- 7. Contain any content that can reasonably be considered to target individuals under the age of 21, including but not limited to images of minors, cartoon characters, toys, or similar images and items typically marketed towards minors, or references to products that are commonly associated with minors or marketed by minors;
- 8. Assert that marijuana items are safe because they are regulated by the Commission or have been tested by a certified laboratory or otherwise make claims that any government agency endorses or supports marijuana.

A licensee may not make any deceptive, false, or misleading assertions or statements on any informational material, any sign, or any document provided to a consumer.

ORS 645-025-8060 also states that, "The Commission prohibits advertising through handbills that are posted or passed out in public areas such as parking lots and publicly owned property."

With the recent announcement of the data breach at Equifax it may be wise for citizens to review their actions to protect their personal information and prevent identity theft. Identity theft typically occurs when a victim's social security number or other personal information is stolen and used to obtain credit cards, loans or commit another form of fraud in the victim's name. Identity theft is one of the fastest growing crimes in the country. Great Willamette River Clean-Up

If left unchecked, English ivy will climb and kill trees. Trees along river and streambanks are essential to water quality and a healthy riparian zone. The CFWWC will provide tools, water, snacks and work gloves. Bring your refillable water bottle, wear sturdy shoes and weather-appropriate clothing. This event is rain or shine. Afterwards, volunteers are encouraged to carpool to Eugene for the Volunteer Thank You Party hosted by Ninkasi for a free pizza lunch, beverages, music, raffle and more.
