League of Oregon Cities Conference

Row River Nature Park Fishing Pond

City Staff was alerted this week by the Oregon Department of Fish & Wildlife that the fishing pond at the Row River Nature Park water level was at least 2 feet lower than normal. Staff investigated the pond and found a beaver dam was blocking the flow of water entering the pond. The beaver dam was removed today, restoring the water flow and bringing the water level up to normal height. City staff is also working on acquiring a new dock for the pond to replace the wooden one removed early this year, as it was not repairable.

South River Road Dog Park Update

The parking lot was paved for the new South River Road Dog Park this week. City staff will be installing parking stops, signage, landscaping, and pouring concrete sidewalk connections to the dog park entry gates. The work is expected to be complete next week. If so, the dog park will be opened for use next Saturday, October 28th. A monument sign and trees will be added later this fall.

Leaf Pickup Next Week

City staff will begin Monday morning picking up leaves that are placed along City streets in approved parking areas. Only leaves will be picked up, no branches, grass clippings or yard debris. Please do not bag your leaves. If property owners do not have approved locations to place the leaves they can be hauled to the Row River Water Treatment Plant at 3300 Row River Road and placed at the leaf drop off site. Additional drop off locations are along River Road in the parking pullouts. Two additional rounds will take place the weeks of November 13th and December 4th.
