I am Kuri Gill, the grants and outreach coordinator at Oregon Heritage, Oregon Parks and Recreation Department. Our office includes the Oregon Main Street Network and the State Historic Preservation Office. The City of Cottage Grove participates in many of our programs and is an Oregon Heritage All-Star Community. I am writing to support funding of the Cottage Grove Main Street Revitalization Project.

Cottage Grove has made a concerted effort to enhance the downtown in order to create a bustling hub of business and entertainment. They have participated in the national Main Street America program through Oregon's Main Street Network to support businesses, draw people to downtown, and improve the look of downtown.

The downtown is also a historic district listed on the National Register of Historic Places. Its significance includes the story of Cottage Grove's development, the proximity to the river, the view through Main Street and the historic buildings. The city and property owners have improved and restored many buildings over the past 10 years. The city offers local façade grants and has leveraged state program. The historic armory building is a community asset like none other, the city has committed to its preservation and its use as a community gathering place in the heart of downtown. The street improvements would increase the local capacity to continue this work.

All of this activity and the events drawing people to the downtown have made clear the need for the street, sidewalk, and accessories improvements. Accessibility is a key challenge, the street arc and deep curbs make walking and getting out of parked cars a burden. Creating more functional outdoor event space will increase opportunities to bring crowds downtown to support business. The street enhancements will improve daily use for business, trucks, autos, and pedestrians.

The city committed to community engagement in the design process, they held several stakeholder meetings and two public meetings. Stakeholder meetings included around 20 people and one public meeting I attend had over 50 people. This level of participation conveys the community commitment to

downtown. The design incorporated environmental and aesthetic concerns, and retains the historic character of downtown. Implementation of such a plan will be a great model for other communities in the state, for the process and the resulting development.

I hope that the need, the level of preparation and especially the community engagement of this project will make the case to fund this project. I am convinced that the funds will be put to good use for a community that values its downtown.

The Main Street Revitalization Project we are seeking funding for strikes a balance between preserving our historic resources and improving infrastructure and streetscapes that support commercial enterprises that attract residents, visitors and business to our downtown corridor. Supporting historic buildings that house businesses that are attractive to today's entrepreneurs are the focus of our Main Street Revitalization Project. Funding from the BUILD grant will ensure we can achieve that goal.

Beyond the goals of encouraging and attracting commercial enterprises, the BUILD grant will ensure we are able to complete the Main Street Revitalization Project's perhaps less glamorous goals of upgrading the antiquated sewer and water systems under Main Street, as well as improving the street's most basic safety features by removing the dangerous rise that has developed along the center divide as a result of years of repaving. To Whom It May Concern:

Cottage Grove has tremendous potential; and it has the passion to improve its historical downtown. And, we could use your help.

Here are three reasons why I'm writing this Letter of Support for the grant request.

- 1. We're Working Hard to Improve Economic Health. I'm investing \$1,500,000 in our Historic Downtown through the purchase and renovation of the "biggest, ugliest building" in the central core. Upon completion, this project will bring at least 30 jobs into the downtown. Upon completion, I plan to start construction on another major project in the downtown that will invest an additional \$5,000,000. Others business owners are also improving their buildings. Clearly, we believe in the potential of Cottage Grove. And, with your grant help, we can and will improve the economic health of our small, rural community.
- 2. Safety and Accessibility is a Significant Need. Not long ago on Main Street near my building, an elderly lady got out of the car's passenger side, tripped, and fell face down on the cement. Bleeding. Why? Because the City's sidewalks are unsafe. They're broken and uneven on nearly every block. Hazardous tree stumps are present in multiple locations.
 - Here's another example. When my wife and I have lunch at a downtown restaurant, she's unable to get out of the passenger door because the Main Street curbs are often too high for a car door to open. That's a big negative for accessibility.
 - Both of these examples illustrate the need to improve safety and accessibility. Your grant could help accomplish these.
- 3. **Quality of Life.** I'm a real estate developer and broker. In order to have a good quality of life for our community, we need private-sector, attractive amenities in our downtown. These will enrich the lives of our citizens. But we need public-sector improvements and repairs to our City's infrastructure. When completed, they both will make a huge difference.

N.B. This note addresses the broader impact of infrastructure improvements over and above the obvious solution to practical needs emphasized in the application

I strongly support the City's application for a BUILD grant to support Main Street revitalization for two reasons:

1. The Main Street re-vitalization project can hasten the evolving transformation of the City into the core of an important regional culture based on the development of natural human and environmental resources. 2. It enhances of its importance as a transportation hub for a widespread rural community and beyond that will benefit from new employment and quality of life opportunities.

Transformation into Regional Culture Center

Dependency on a local culture that no longer exists and an environment that is yet to be adequately exploited makes change both essential and possible. Considerable potential exists because recent population growth has brought new skills and opportunity. Fortunately, local government knows how to respond.

Important social and economic improvement has been achieved by public and private partnerships based in part on the strong support of families central to previous activity including both large employers and workers.

The term "Revitalization" is misleading because the purpose is to facilitate new opportunity rather than update history. The proposed enhancements respond to local needs but have broader significance because they help the City become a regional center of character.

The resources for this reformation already exist in a broad range of interlocking practical and intellectual strengths. These include existing institutions like a large hospital, a well used library, an exemplary school system, airport, and commercial activity including a nationally recognized wine industry and a comprehensive range of professional offices, many well maintained sport facilities and fast growing entertainment venues. Vigorous organizations like Rotary have members who are community leaders with the understanding and experience to facilitate new activity based on infrastructure improvements.

The potential importance of Main Street as a cultural center cannot be over emphasized. Cottage Grove has recognized historic importance centered on Main Street and its immediate environment and has structures and interconnections conducive to a range of activity essential to a new identity.

Of special importance is the remarkable collaboration between local philanthropists and government notably in the conversion of a one time railway yard into beautiful park and auditorium that is only a few hundred yards from Main Street. (The City Manager has already been able to arrange visits from the Eugene Symphony and there is already a range of other lively entertainments in the park. Another remarkable achievement has been the conversion of a large military

armory into a multi purpose community center capable serving social needs and providing a quality environment for cultural activities.

Of significant economic importance is how an improved cultural environment will attract investment in new business with an attendant increase in employment, property values and tax income.

Most importantly, in connection with the City's application, the cultural potential can only be fully realized by essential improvements to the infrastructure of the inner city.

Enhancing Cottage Grove as a Transportation Hub

Cottage Grove is already a transportation hub for a widespread rural community and, importantly, it is connected with Interstate I-5 that generates a significant flow of visitor traffic into Main Street and its hinterland.

Equally important is the inward and outward regional traffic of Cottage Grove. Proximity to Eugene has made Cottage Grove an important commuter town that also encourages travel from Eugene. This reverse flow is important to the local economy. And it is key to bringing in new employers because it taps a reserve of

needed talent attracted by a fast improving local quality of life and lower property costs.

The potential benefits could not be fully realized if the internal infrastructure is not improved. This not only includes seamless internal traffic flows but access to and egress from the surrounding region.

City government has proved its capability to manage far reaching improvements but adequate funding is now essential.
