(a) Public Hearing for Ordinance Amending the Cottage Grove Comprehensive Plan Land
Use Diagram Map & Title 14 Land Use District Map for 2110 W Main St. (Map 20-03-29-34 TL 00500) (MCPA 3-23)

Kathleen Matteson, Cottage Grove, Oregon expressed concern about increased population, infrastructure, traffic and the need to improve our roads.

Assistant City Planner Allison Crow explained dates referenced in the housing needs analysis and reminded Council that this ordinance is a down zone, decreasing from High Density to Medium Density.

(c) Ordinance Amending the City of Cottage Grove Municipal Code Title 14 Land Use, the Citywide Zoning Map for Double H Investments LLC, ZC 2-23, Map/Tax Lot 20-03-32-00-00504 (Land Partition Plat No. 2019-P2897, Parcel 1)

Assistant City Planner Allison Crow explained that as a requirement of annexation, the property owner must apply for a zone change to re-designate the zoning from County to City zoning. She said the Planning Commission held a Public Hearing on October 18, 2023 and voted 5-0 in favor of applying the R-1 Zone and it is recommended that Council hold a vote to consider ratifying the decision.

BUSINESS FROM THE CITY COUNCIL

(a) 2023 Municipal Court Report

Municipal Court Judge Martin Fisher presented to Council a written Annual Report. He highlighted information contained in the report and elaborated on the categories of crime and violations, caseload and collections, trials and the closure of the jail.

Judge Fisher and Council discussed collections, suspension of licenses, the inability to hold people accountable, public safety, new officer training, community service options and use of the Springfield jail.

(b) Parking Restrictions on Jim Wright Way

Public Works and Development Director Faye Stewart explained traffic concerns on Jim Wright Way in the area of The Cottage Theater during productions. He said the City Engineer has recommended establishing a No Parking Zone on the Northside of Jim Wright Way along the Cottage Theater property to improve safety for motorists.

Discussion was held about the width of travel lanes, visibility of oncoming traffic on the corner, and potential opportunities to park in the lot to the west of the theater.
