SUBJECT: A RESOLUTION TO AMEND THE PURCHASING AGREEMENT BETWEEN AXON ENTERPRISES, INC. AND THE CITY OF COTTAGE GROVE.

DATE: March 18, 2024

### Background

In December, 2022 the City of Cottage Grove entered into a purchasing agreement with Axon Enterprises, Inc. for the purchase of hardware and software to include body worn cameras, Taser, docking stations, and digital evidence management software.

The initial agreement and order was for the purchase of 15 body worn camera packages that include the software license for evidence management for the duration of five (5) years. Current Cottage Grove Police Department policy requires all uniformed members of the department be equipped with a body worn camera. The current budgeted staffing level for the department is 20 uniformed personnel. This includes the Chief, Captains, Sergeants, Police Officers, and Community Service Officer.

The initial agreement did not include software licenses for the two evidence / records specialists to manage the digital evidence. These software licenses can be added as a stand-alone product that does not require the body worn camera package.

### Recommendation

That the Council adopt the resolution to amend the purchasing agreement between Axon Enterprises, Inc. and the City of Cottage for the remaining four (4) years for the purchase of five (5) body worn camera packages and two (2) software licenses.

WHEREAS, the Cottage Grove Police Department has increased staffing, thus needs to add equipment and software licenses to the City's original interstate cooperative procurement; and

WHEREAS, the City Council has reviewed the proposed addendum for the purchase of five (5) additional body worn camera packages and two (2) software licenses to be added to the remaining four (4) year term of the Axon Contract, and has determined that it is in the best interest of public safety to approve the proposed amendment.

NOW, THEREFORE, BE IT RESOLVED that Resolution 2083, Exhibit A is hereby amended to append Addendum 1, attached hereto and by this reference incorporated herein, to its Axon Contract.

BE IT FURTHER RESOLVED that the City Manager is hereby authorized to sign Addendum 1 to the Axon Contract to purchase of five (5) additional body worn camera packages and two (2) software licenses.

BE IT FURTHER RESOLVED that all unamended provisions of Resolution 2083, including all unamended provisions of the Axon Contract, attached as Exhibit A to Resolution 2083, remain in full force and effect.

BE IT FURTHER RESOLVED, that this Resolution shall take effect immediately upon its passage.

WHEREAS, the contract with Axon will provide the Cottage Grove Police Department with body-worn cameras and all associated equipment and support and related critical police equipment; and


WHEREAS, the City Council has reviewed the proposed contract and has determined that it is in the best interest of public safety to approve the contract.
