SUBJECT: A RESOLUTION ESTABLISHING APPROPRIATIONS WITHIN THE GENERAL FUND FOR THE EXPENDITURE OF AN UNFORESEEN SPECIFIC PURPOSE GRANT FROM THE AMERICAN RESCUE PLAN ACT.

### Background

The City has received a specific purpose grant from the State of Oregon, Department of Administrative Services, known as the American Rescue Plan Act (ARPA) aimed at providing relief to government organizations dealing with the effects of COVID-19, in the total amount of \$1,162,216 during fiscal year 2021-22, allocated as a resource to the General Fund in the amount of \$867,711, to the General Reserve Fund in the amount of \$283,876; and to the Special Trust Fund in the amount of \$10,629. The grant was unknown at the time the original budget was adopted for fiscal year 2021-22.

The amount in the Special Trust Fund is not appropriated, as the grant funding is eligible to be used for the stated purposes on or after March 3, 2021. Fundraising to support the Eugene Symphony community event did not occur as anticipated in the previous fiscal year, leaving a shortfall. The grant will be received in the Special Trust Fund, in order to cover the shortfall.

In order to lawfully spend the money, the City must comply with the requirements of Local Budget Law. Expenditures in the year of receipt of grants, gifts, bequests or devises transferred to the local government in trust for a specific purpose may be made after enactment of a resolution or ordinance authorizing the expenditure. [ORS 294.338 (2)]

#### Recommendation

Staff recommends that the City Council adopt the resolution to establish appropriations for the use of the grant funds for the purpose stated in the amount of \$1,151,587, and recognition of grant receipts in the Special Trust Fund in the amount of \$10,629, for a total of \$1,162,216.

WHEREAS, the City Council may, by resolution, increase the appropriations in the adopted budget for the expenditure of a specific purpose grant if the grant was unknown at the time the regular budget was adopted per ORS 294.338(2).

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Cottage Grove hereby appropriates a specific purpose grant from the State of Oregon, Department of Administrative Services, for the American Rescue Plan Act:
