I have served for one year on the Cottage Grove finance committee. I've participated in a number of community/city events including the VisionKeepers, and am a graduate of the Ford Family Foundation leadership program. I've also run for office a number of times over the years and am relatively familiar with the duties of city councilors.

1. Please explain why you are interested in the appointment and what you, as a City Councilor, would offer to the City Council and the community.

I've been interested in serving as a city councilor for many years, primarily to be part of the bridge between the community and city government. I am especially familiar with downtown, and as a property owner and non-profit founder I have a good working relationship with the downtown community, as well as strong insights into the issues facing the downtown community.

2. Please describe what you believe are the major concerns of the City residents and businesses. How do you think these concerns should be met by the City?

The list of concerns is long and varied. Downtown revitalization, generating income from freeway traffic, road conditions, and taxes are perennial focuses. In recent times, COVID policies were high on the list. Currently, how to best address the growing homeless population is a major focus. There is no specific answer to "how I think these concerns should be met" but in general, costs and benefits must be carefully examined and the experience of other small cities should be taken into account. Community input should be gathered, especially when the community is directly affected. I am a strong believer in using city resources to the greatest benefit of all people involved, from business owners to wage workers to those needing public assistance.

3. Please explain why you think the City of Cottage Grove should do or accomplish to improve the City and the City government.

The city population and government are currently divided by the same deep political trends that are breaking up communities nationwide. Beyond managing the city responsibly, I believe the city government should be working to bridge that divide and build trust and stronger community bonds, both within the government and among the residents of Cottage Grove. As leaders/representatives of the community, we should highlight common interests and serve as an example of cooperation or, at worst, neighborly disagreement.

4. Please provide any additional information or comments which you believe will assist the City Council in considering your application.

I am currently involved in a work project that has me in California until the end of March. I can participate in interviews and meetings via teleconference only until after that. After this commitment is finished, I can refuse other opportunities that take me out of town for extended periods..
