## Background

The City has received a grant in the amount of \$6,000 from the State Historic Preservation Office, Oregon Heritage. The grant is to be used specifically to provide funding for a consultant to conduct a market analysis for the Historic District.

In order to lawfully spend the money, the City must comply with the requirements of Local Budget Law. Expenditures in the year of receipt of grants, gifts, bequests or devises transferred to the local government in trust for a specific purpose may be made after enactment of a resolution or ordinance authorizing the expenditure. [ORS 294.338 (2)]

Staff recommends that the City Council adopt the resolution to establish appropriations for the use of the grant funds for the purpose stated in the amount of \$6,000.
