Background

Included with your packets are two proposed tools to assist Council with managing its workload; an Issue Tracker and Pending City Council Agenda Items. Both are taken from prior work environments in my career and helped us create additional transparency with the respective communities.

Discussion

The Issue Tracker is a means of responding to requests for additional tasks from Council. Items are added to the Tracker upon direction from a majority or consensus of Council. Designated responsible parties (generally staff) are shown as well as status, estimated duration, and estimated completion of date of task.

As this is a fluid document and tasks are shown generally in priority order, Council may add, subtract or otherwise revise the tracked projects at its discretion. Such tasks are in addition to the normal staff obligations and responsibilities.

The initial Tracker has listed several efforts that we are asking Council to review and provide direction on. Staff can respond to any questions.

The Agenda Planning Calendar is similarly a continuous work in progress. At our regular staff meetings we will review this carefully and attempt to update and modify as needed. This will be included with the normal agenda packets as informational not requiring any further action, but certainly may be discussed as you choose.

Recommendations

The City Council is not being asked to approve either of these tools but rather just provide input as to contents. Specifically, the Issue Tracker is in need of Council direction and subsequently will be a regular part of the City Manager's report.
