Background

Council appointed a Subcommittee to conduct interviews of candidates for the Urban Forestry Committee vacancies created by term expirations on 12/31/2023. The Subcommittee was appointed at the November 27, 2023 City Council Meeting. The Subcommittee is staffed by Councilor Savage (Chair), Councilor Merryday, and Councilor Fleck.

The Urban Forestry Committee began the year with three vacancies with one being filled to date (Reilly Newman). At this time there are two applications for the remaining two vacancies. One applicant is Justin Tidrick (application attached). The other is Richard Vasquez (application attached), who has also applied for a position on the Budget Committee. The Subcommittee has interviewed Mr., Tidrick and Mr. Vasquez and are prepared to make their recommendation to the Mayor and Council.

Councilor Savage as Chair of the Subcommittee will present the recommended appointments to Mayor and Council at the March 11, 2024 City Council Meeting. The selected appointees will serve a three-year term beginning March 11, 2024 and expiring December 31, 2026.
