(a) CITY OF COTTAGE GROVE— ZONE CHANGE (ZC 2-22) TO REZONE THREE UN ADDRESSED PARCELS, COTTAGE GROVE, OR 97424; MAP/TL 20-03-33-33-01300, 20-03-33-33-01400, & 20-03-33-33-01500 TO R1— SINGLE-FAMILY. Applicant is seeking rezone approximately 0.41 acre to R-1 Single-family Residential from AGT-5. Relevant Criteria: 14.47.500 Criteria for Legislative & Quasi-Judicial Amendments. Applicant City of Cottage Grove, 400 E Main Street, Cottage Grove, OR 97424.

Eric explained that this Zone Change application is to rezone three parcels that are located at the end of Hayes and Grant Ave. They are currently undeveloped lots. At the time they were brought into the City of Cottage Grove the comprehensive plan designation of low density residential R1 map was not applied. This application is a house keeping item to apply the land use map designation of R1 (Low Density Residential) to these parcels.

Staff was provided written comments from the Housing Coalition Council of Oregon requesting that we increase the quantity of findings for Goal 10 (which is the housing goal.) It is Staff's opinion that this particular intervener is misunderstanding the application, thinking that we are seeking to apply a zone that would be an amendment to the comprehensive plan, which it is not. Staff did add some language to address the 2018 buildable lands inventory showing that we do need more residential lands. Staff recommends approval.

(b) CITY OF COTTAGE GROVE – DEVELOPMENT CODE TEXT AMENDMENT (DCTA 1-22) TO AMEND TITLE 14 DEVELOPMENT CODE RELATED TO FLOOD DAMAGE STORMWATER MANAGEMENT CHAPTER 14.35. This amendment will add Section 14.35.200 Stormwater Detention & Treatment. Relevant Criteria: 14.41.500 Decision-making criteria. Applicant: City of Cottage Grove, 400 Main Street, Cottage Grove OR 97424.

Eric explained that this Development Code Text Amendment application would add to Chapter 14.35- Stormwater Management Requirements for onsite detention and treatment of stormwater. This will only be applied to parcels larger than half an acre when they begin their hardscape development.

The Commission and Staff discussed the reasons for this amendment, and what type of properties it would affect and why. Eric said that Cottage Grove will be adopting the City of Eugene's Stormwater Manual and explained the reasons for this.
