(a) CITY OF COTTAGE GROVE - COTTAGE GROVE URBAN RENEWAL PLAN. The Cottage Grove Planning Commission will be reviewing the proposed Cottage Grove Urban Renewal Plan for conformance to the Cottage Grove Comprehensive Plan and making a recommendation to City Council.

Elaine Howard, Elaine Howard Consulting, LLC, utilized a PowerPoint (attached) to present the proposed Urban Renewal Plan to the Commission. She noted the key elements of the plan, the Planning Commission's role at this point and what the key pieces in the adoption process going forward are. She then read through the findings in the staff report.

Elaine noted that the South Lane Fire District has asked for a portion of what is proposed to be allocated be directed to the Fire District for equipment. The Fire District will be added to Public Facilities and Services.

The Commission discussed potential projects and asked for clarity regarding interest rates. They also noted the possible positive impact of hotels, infrastructure and the downtown historic district.

Elaine mentioned that the City of Sutherlin has done a wonderful job with their Urban Renewal and that it would be of benefit to follow up with them on their process.

The Commission questioned the omission of Coiner Park on the map and had questions regarding assessed values and tax payer impact.

Commissioner Burback made a motion. Commissioner Christopher repeated the motion that the Cottage Grove Planing Commission finds, based upon the information provided in the staff report and the provided attachments, that the Cottage Grove Urban Renewal Plan conforms with the Cottage Grove Comprehensive Plan. Commissioner Burback seconded. All were in favor 7-0. Motion passes.

Elaine noted that the Planning Commission should watch the recording of the September 22 City Council meeting to see the Urban Renewal 101 presentation for more specific details on the proposed plan.
