**1036 INTERCHANGE LANDSCAPE IMPROVEMENTS
ADDENDUM NO. 1**

TO: ALL PLAN HOLDERS AND PERSPECTIVE BIDDERS

This Addendum No. 1 is issued in accordance with the contract documents for 1036 INTERCHANGE LANDSCAPE IMPROVEMENTS. All provisions of the aforesaid Contract Documents shall remain in full force and effect except as otherwise specifically set forth in this Addendum No. 1 which is hereby made a part of the Contract Documents as fully and complete as if the same were fully set forth therein:

ITEM

- 1. Delete the following items from the Bid Form; the City will procure and store the following at the public works yard at 425 N 14th Street, Cottage Grove:**

- 2. Change bid date from Tuesday, May 4, to Thursday, May 6, 2021; time remains 2:00 pm. All else remains the same per the Instruction to Bidders.**

3. **Special Provisions: General – G-01 WORK INVOLVED:** Replace the following text “The project consists of the reconstruction of [enter Architect’s scope of work description]” with the following:

“The project consists of the construction of a new irrigation system and landscape plantings within the Oregon Interstate 5 interchange (Exit 174), and north of the E Cottage Grove Connector. The works include all materials, labor, and other requirements as outlined in the Contract Documents or inferred by the Contract Documents, necessary to complete the project.”

4. Replace General Conditions, 4.11 Insurance, C. General Insurance Requirements: with

“The Contractor shall maintain in force for the duration of this agreement a Commercial General Liability insurance policy written on an occurrence basis with limits not less than \$2,000,000 per occurrence and \$4,000,000 in the aggregate. Automobile Liability (owned, non-owned and hired) insurance with limits not less than \$2,000,000 per occurrence shall be maintained. The City, its employees, officials and agents will be named as additional insured with respect to work or services performed under this agreement. This shall apply to both work in progress and completed operations. This insurance will be primary over any insurance the City may carry on its own.”

ALL BIDDERS SHALL ACKNOWLEDGE RECEIPT AND ACCEPTANCE OF THIS ADDENDUM NO. 1 IN THE PROJECT BID AND SHALL SIGN THE ADDENDUM BELOW AND SUBMIT IT WITH THE BID PACKAGE. BIDS SUBMITTED WITHOUT ACKNOWLEDGEMENT OF OR WITHOUT THIS SIGNED ADDENDUM NO. 1 WILL BE CONSIDERED NONRESPONSIVE.
