Tree Report

February 8, 2023

Location: <u>1215 East Washington Avenue</u> (Alley behind address)

RE: 2 Spruce Trees & 1 Cedar Tree

Spruce Tree #1:

- 60' tall x 2'11" diameter
- Codominant stems 12' up with multiple tops
- Covered in Ivy
- Multiple targets with heavy lean angle
- Utilities conflicted

Spruce Tree #2:

- 6' tall x 1'8" diameter
- Utilities conflicted
- Multiple targets with heavy lean angle

Cedar Tree:

- 65' tall x 3'4" diameter
- Codominant stems with multiple tops
- Signs of included bark and shearing
- Utilities conflicted
- Multiple targets with heavy lean angle

These trees are in an alleyway right outside of a fence. One tree in this area has already fallen unexpectedly. Upon inspection, this tree was also covered in Ivy and was completely rotten. I see no reason that the other trees won't also fall unexpectedly in the near future.

Given the location of these trees and the potential for causing damage to houses and utilities, I recommend that these trees be removed.
